Item 9: Other Events

SN Aboitiz Power Hydro, Inc., a consortium between Aboitiz Equity Ventures, Inc.'s subsidiary Aboitiz Power Corporation (AP) and SN Power AS of Norway, submitted the highest bid for the Ambuklao-Binga Hydroelectric Power Complex consisting of the 75MW Ambuklao Hydroelectric Power Plant located at Bokod, Benguet and the 100 MW Binga Hydroelectric Power Plant located at Itogon, Benguet. The price offered amounted to US\$325 million.

The Ambuklao-Binga hydroelectric complex will be a significant addition to AP's generating capacity following its successful bids for the Magat hydropower project in Isabela and for a stake in the STEAG State Power, Inc. coal-fired power plant in Misamis Oriental.
