At its regular meeting held today, the Board of Directors of Aboitiz Equity Ventures, Inc. (AEV), approved the amendment of AEV's Internal Audit Charter and By-Laws. The amendment to AEV's By-laws consists principally of deleting the following requirement:

Article I (Stockholders' Meeting), Section 6. Proxy -

Last May 18, 2009, AEV's shareholders delegated to the Board of Directors the authority to amend AEV's By-laws to give the Board greater flexibility to amend provisions of the By-laws to comply with regulatory requirements and current governance best practices. The notarization requirement was removed to facilitate voting by stockholders in line with AEV's continued efforts to improve corporate governance practices.
